Licensing Procedures

FIRE PROTECTION SYSTEM LICENSING INFORMATION AND REFERENCES

The Delaware State Fire Prevention Regulations (DSFPR) require that all Fire Alarm Signaling and Fire Suppression System Companies be licensed through the Office of the State Fire Marshal.

The following will assist with obtaining the applications and information to submit for Fire Protection System Licenses and Certificates.

Fire Alarm and/or Fire Suppression Licenses/Certificates

 - ♦ Fire Alarm Signaling Chapter 4
 - Fire Suppression (all types except for Fire Extinguishers) Chapter 5
 - ♦ In-House Fire Alarm Signaling Chapter 6
 - ♦ In-House Fire Suppression Chapter 7
 - Monitoring Chapter 8 Central Station and Remote Station Services
- ♦ Exam Requirements (<u>www.statefiremarshal.delaware.gov</u> Go to Technical Services / Fire Protection Systems Licensing Requirements & Quality Assurance Forms
- ◆ DSFPR Exam Application (Application for Special Testing DSFPR Class V Fire Alarm & Class IV Fire Suppression exam) (www.statefiremarshal.delaware.gov / Technical Services / Licensed Public Fire Protection Companies & Testing Applications / Delaware State Fire Prevention Regulation Exam / Class V Fire Alarm Exam / Class IV Fire Suppression Exam Application)
- ◆ Complete Fire Alarm Signaling and/or Fire Suppression Systems Company **License Application** and submit with **required documents** and **fee** (noted on application)
- ◆ Complete Systems **Certificate Holder Application** and submit with **required documents** and **fee** (noted on application)

Fire Extinguisher Licenses

Issued to each individual

- ♦ Review **Regulation 703**, (License Regulations) Go to www.statefiremarshal.delaware.gov / Regulations, Appeals & Alternatives / Delaware State Fire Prevention Regulations (DSFPR) / Regulation 703, then scroll to
 - ♦ Fire Extinguishers Chapter 2
- ♦ Complete Fire Extinguisher License Application
- ♦ Schedule and successfully pass the **Fire Extinguisher exam** given by the Office of the State Fire Marshal
- ♦ Upon successful passing, submit required **fee**

Applications are to be typed or handwritten, and submitted to the office with an original signature. Do not submit license or certificate holder applications by e-mail.
