The 153rd General Assembly passed, and the Governor has signed House Bill 124, which raises fees that the Office of the State Fire Marshal charges for licenses and permits.

Effective January 1, 2026, fees that the Office of the State Fire Marshal charges shall be raised as detailed below:

- 1) **Place of Assembly License:** \$100.00 annually.
- 2) **Place of Assembly Special Events:** \$100.00 per event.
- 3) **Amusement Ride Fees:** \$100.00 per ride annually, not to exceed a total of \$400.00.
- 4) **Amusement Attraction-Single Event:** \$100.00 per event.
- 5) **Bowling Lanes:** \$100.00 per event.
- 6) **Burning:** \$100.00 per event.
- 7) **Blaster's License:** \$100.00 annually.
- 8) **Explosives Sale, Storage, Transport License:** \$100.00 annually.
- 9) **Explosives Single Event Fee:** \$100.00 per event.
- 10) **Exhibits, Craft, Trade Shows:** \$100.00 per event.
- 11) **Flammable/Combustible Liquids Service Stations and/or Tank Installations/Fuel Dispensing:** \$100.00 annually.
- 12) **Fireworks Shooters License:** \$100.00 annually.
- 13) **Fireworks Public Display and Transportation Fee:** \$100.00 per event.
- 14) **Covered Malls:** \$100.00 annually
- 15) **Fun House/Haunted House:** \$100.00 per event.
- 16) **Public Accommodations (Hotels, Motels, Bed and Breakfasts, Rooming, Lodging, and Boarding Houses:** \$100.00 annually.
- 17) **Liquified Petroleum Gas Dispensing or Tank Storage:** \$100.00 annually.
- 18) **Fire Alarm Central Station, Remote Station, or Monitoring Service or Company License:** \$100.00 annually.
- 19) **Fire Alarm System Company License.** \$100.00 annually
- 20) **Fire Alarm Signaling System Certificate Holder:** \$100.00 annually.
- 21) **Fire Suppression System Company License.** \$100.00 annually.
- 22) **Fire Suppression System Certificate Holder.** \$100.00 annually
- 23) **In-House License Fees.** \$100.00 per system for each fire protection system serviced by the system owner.
- 24) **License To Service Portable Fire Extinguishers:** \$100.00 annually.
- 25) **Certificate of Inspection:** \$25 per fire protection system.
- 26) **Food Truck License:** \$50.00 annually.
- 27) **Impairment of Fire Protection System:** \$50.00 per incident.
- 28) **Outdoor Tire Storage and Disposal Sites:** \$100.00 annually.
- 29) **Tent Permits:** \$100.00 per event.
