Provide documentation that you are a full-time employee of the Fire Suppression Company (letter on company letterhead, signed and dated, from authority stating you are a <b>full-time</b> employee)</li> <li>5. Provide official documentation which shows that you have successfully completed the examinations prescribed by the State Fire Prevention Commission. For all Certification Classes, except Class VIa and Class VIIa, you may provide official documentation which shows that you are a Registered Delaware Professional Engineer instead of documentation of successful completion of prescribed examinations.</li> <li>6. Read the Limitations section and sign at the bottom of this page</li> </ol>

<b>5 Limitations</b>
<p>A Certificate Holder may only perform the functions for which they hold a certificate. The authority of the Certificate Holder on behalf of the company shall <b>cease immediately upon separation</b> of the Certificate Holder's relationship with the company or upon expiration of the certificate held by the Certificate Holder. The Certificate Holder and the company are each required to <b>notify</b> the State Fire Marshal in writing within five (5) business days of the separation between them. Upon the expiration of the current license or within six months (whichever occurs last) if the company has not obtained a Certificate Holder on its staff, the State Fire Marshal shall terminate the company's license.</p>
